Administrative Report Highlights:

Mr. Jewell indicated that the City of Rochester Hills City Council a Public Hearing for the 2018 Fiscal Year Budget and was passed and final vote from the City Council will be in October.

The City of Rochester Council tabled the request to approve the 2018 Fiscal Year Budget until the next Council meeting on September 25th.

Discussion followed regarding Orthopedic Spine & Sports Therapy, opportunities for RARA's participants and the community to have OSST located at 480 Fitness.

Mr. Word indicated that there has been an increased interest in the 480 Fitness building and the fall promotion for new or returning members. Mr. Word reported that the big screen tv has been installed on the far wall of the fitness area and painting of the wall will be completed this week.

Mr. Word indicated that Heroes Vs Villains Kids 1 Mile Run is scheduled for October 6th. There are close to 100 participants registered as of September 8th with most of them being Heroes.

Commissioner Peterson indicated that she would like any information on RARA's special events and programs so she can get the information out to the City of Rochester's Council and residents. Commissioner McConnell also ask to have the information sent to her for distribution.

Mrs. DiCaro indicated that Adaptive Instructional and West Wednesday Night basketball leagues will be moving to the 480 building basketball courts starting September 27th.

Volleyball has increased for the 3rd straight year with the addition of a league for 6th through 8th grade.

Mr. Cribbs also indicated that in January he will be offering sponsorship opportunities for business's in the area by putting their company's name on the back of each players jersey for a fee.

Mrs. Castile indicated that dance started this week and waiting for 71 people to complete the registration process. Autism Movement Therapy classes have been added to the fall dance schedule. SPT will be participating in the Upcoming Chairi Walk on September 23rd.
